The Lockdown has also blocked movement of raw material and finished goods. In the circumstance, our Company has shut down the polyester manufacturing operations at its Patalganga Plant, in Maharashtra w.e.f. 25<sup>th</sup> March '2020 for combating with Covid-19 pandemic effect. Since the above closure is for the reasons beyond the control of the company, we are unable to assess the impact as of now.

Employees' well-being and safety are matters of utmost priority for the Company. We are carefully monitoring the rapidly evolving situation due to Covid-19 pandemic and ensure safety and health of all our employees and compliance with various directives being issued by Central/State/Municipal authorities from time to time. All the employees in our offices have already been instructed to work from home in order to maintain business continuity as far as possible.

The duration of this plant shutdown will depend upon the evolving situation / directives to be issued by the Government authorities. The Company will continue to monitor the situation and take appropriate action as required from time to time.
