अंबाला में मासूम बच्ची की नाले में डूबने से मौत

अंबाला, 12 नवंबर (जनसत्ता)।

आज शुक्रवार दोपहर अंबाला शहर में हिसार रोड के समीप सिंघावाला में घटित एक बेहद दर्दनाक हादसा हुआ जहां नाले में डूबने से 3 वर्षीय एक बच्ची की मौत हो गई। पीड़ित बच्ची का नाम कनिका था जिसके पिता प्रवासी मजदूर हैं और सिंघावाला में ही किराए के एक मकान में रहते हैं। उनके 5 बच्चे हैं, जिनमें 2 लड़के और 3 लड़कियां हैं व कनिका चौथे नंबर की बच्ची थी।

आज शुक्रवार सुबह वह खेलते-खेलते वहां नाले में जा गिरी। घटना के समय बच्ची के पिता दिहाड़ी पर गए हुए थे जबकि उसकी मां घर पर ही थी। मां ने सोचा कि बेटी बाहर कहीं खेल

रही होगी लेकिन उनके ही एक पड़ोसी ने बच्ची को नाले में डूबते देख पुलिस को सूचित किया तो सदर के थाना प्रभारी सुरेश सैनी दलबल सहित मौके पर पहुंचे और बच्ची का शव बाहर निकालकर स्थानीय सिविल अस्पताल के शव गृह में रखवाया।

दरअसल अंबाला में यह नाला पिछले कई साल से कच्चा पड़ा है जिसमें गाद भरी है। चुनाव के समय सभी सियासी दल इसे पक्का कराने का वादा तो कर जाते हैं लेकिन आज भी इसकी हालत बेहद खराब है। आज तक इस पर कंक्रीट का लेंटर नहीं डाला गया और न ही इस पर कोई दीवार बनी है। कोई भी खेलते-खेलते इसमें गिर सकता है।
