We have conducted the review of the compliance of the applicable statutory provisions and the adherence to good corporate practices by **Hindustan Appliances Limited CIN: L18101MH1984PLC034857**(hereinafter referred as 'the listed entity'), having its Registered Office at 1301, 13th Floor, Peninsula Business Park, Tower B Senapati Bapat Marg, Lower Parel (West), Mumbai – 400013.
