The disclosures under above said regulations were already mailed to BSE authorities and also hereby submitting for your kind authorities for your reference.

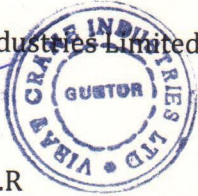
