The Board of Directors had approved a multi-year supply chain agility programme on 24th Jan.'23 and the same was mentioned as part of the press release as well as notes to December 2022 financials which were forwarded to exchanges. As part of aforesaid multi-year supply chain agility programme, United Spirits Ltd. ("Company") has closed its factory operations at the manufacturing unit located at Rosa, Village Rousarkothi, Post Rousarkothi, Dist. Shahjanpur, UP – 242406 ("Unit").
2. Please find below details of the closure of the Unit pursuant to Para B of Schedule III of Listing Regulations.

3.	Date of closure or estimated time of closure.	31 st October, 2023
4.	Reasons for closure.	Unit is a 200 plus year old factory which has very old infrastructure and depleted machinery with age old technology. Replacing such machinery and technology would have huge cost to the company which is not viable as per the current market conditions. Hence, as part of the multi-year supply chain agility programme of the company, the management of United Spirits Ltd. decided to close the operations at the Unit. Closure of the Unit is part of the multi-year supply chain agility programme that was approved by the Board of the Directors of the Company on 24th January, 2023 and same was intimated to your good offices on 24th January, 2023.
