हास्य और एंथोनी के वकीलों ने शीघ्र अदालत के इस आदेश का हवाला देते हुए उच्च न्यायालय से गुहार की कि समानता के न्यायिक सिद्धांत के आधार पर उनके मुक्तिपत्रों को भी जमानत का लाभ दिया जाना चाहिए।

उधर, अभियोजन ने दावा किया कि मामले में प्रावधान के तहत वैधानिक प्रक्रिया का पालन किया गया था और निचली अदालत के एक आदेश में भी इस बात का उल्लेख किया गया है।

राज्य में सत्तारूढ़ भाजपा की स्थानिय विधायक मालिनी लक्ष्मण सिंह गौड़ के बेटे एकलव्य सिंह गौड़ ने विवादस्पद कार्यक्रम में हिंदू देवी-देवताओं, केंद्रीय गृह मंत्री अमित शाह और गोधरा कांड का आरोप लगाते हुए एक जनवरी की रात प्राथमिकी दर्ज कराई थी।

मामले के छह आरोपियों में शामिल सदाकत खान को दो जनवरी को गिरफ्तार किया गया था। सत्र न्यायालय ने नियमित जमानत के लिए खान की दूसरी अर्जी नौ फरवरी को खारिज कर दी थी।

कोविड-19 के कारण 592 रेल कर्मियों की मौत : सरकार

नई दिल्ली, 12 फरवरी (भाषा)।

कोविड-19 महामारी के कारण अब तक 592 रेल कर्मचारियों की मौत हुई और इस दौरान न तो किसी कर्मचारी को बिना वेतन के छुट्टी पर भेजा गया और न ही ऐसा कोई कर्मचारी है जिसे 2020 में वेतन नहीं मिला हो।

रेल मंत्री पीयूष गोयल ने शुक्रवार को राज्यसभा में एक सवाल के लिखित जवाब में यह जानकारी दी। मार्क्सवादी कम्युनिस्ट पार्टी (माकपा) के विनय विश्वम ने सरकार से जानना चाहा था कि मार्च 2020 से कुल कितने कर्मचारियों को बिना वेतन के छुट्टी पर भेजा गया और वर्तमान में कितने रेल कर्मचारी हैं जिन्हें इस दौरान एक महीने से अधिक समय से वेतन प्राप्त नहीं हुआ है।

इसके जवाब में गोयल ने कहा, 'कोविड-19 के कारण ऐसा कोई भी रेलवे कर्मचारी नहीं है, जिसे छुट्टी पर भेजा गया अथवा जिसे मार्च 2020 से वेतन नहीं मिला।' इसके साथ ही एक अन्य सवाल के जवाब में रेल मंत्री ने बताया कि इस महामारी के दौरान 32,641 रेलवे कर्मचारियों को कोरोना वायरस से संक्रमित हुए थे।

इसके साथ ही उन्होंने कहा, 'कोविड-19 के कारण 592 रेलवे कर्मचारी की मृत्यु हुई है।' गोयल ने बताया कि कोरोना संक्रमित रेल कर्मचारियों के उपचार के लिए 48 कोविड देखभाल केंद्र उपलब्ध हैं।

इसके साथ ही उन्होंने कहा, 'वित्त मंत्रालय ने विश्व बैंक और एशियाई विकास बैंक के माध्यम से रेल मंत्रालय को कोविड संबंधी व्यय के लिए सहायता मुहैया कराई है।'
