- I, Geeta Roy Chowdhury, appointed as the Scrutinizer by the Board of Directors of Texmaco Rail & Engineering Limited to conduct the Postal Ballot and for the purpose of scrutinizing the process of remote e-voting which commenced from 9:00 a.m. on Sunday, 16th June, 2024 and ended at 5:00 p.m. on Monday, 15th July, 2024 for the item as stated in the Postal Ballot Notice ('Notice') dated 16th May, 2024, submit my report as under:
- 1. The e-voting services were provided by M/s. KFin Technologies Limited ('KFin').
- 2. The Company has completed the dispatch of Notice to its Members on 15th June, 2024 through email, in compliance with the provisions of the Companies Act, 2013 ('Act') read with relevant circulars issued by the Ministry of Corporate Affairs ('MCA'). Further, in accordance with the provisions of the Act read with the relevant circulars issued by the MCA & the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('Listing Regulations'), the Company has extended only the remote e-voting facility to its Members, to enable them to cast their votes electronically instead of submitting the postal ballot form and accordingly, no postal ballot forms were sent to the Members.
- 3. The Company had published an advertisement on 16th June, 2024 in newspapers namely, Financial Express and Aajkaal, informing the shareholders the details relating to the Notice including the completion of dispatch of the Notice, in compliance with the applicable provisions of the Act read with the relevant circulars issued by the MCA and the Listing Regulations.
- 4. Voting rights were reckoned on the shares registered in the name of Members, as on Friday, 7th June, 2024 (i.e. the cut-off date).
- 5. The remote e-voting period commenced at 9:00 a.m. on Sunday, 16th June, 2024 and ended at 5:00 p.m. on Monday, 15th July, 2024. The e-voting module was blocked thereafter.
- 6. After the conclusion of remote e-voting, the votes cast by the Members through e-voting facilty was unblocked on Monday, 15th July, 2024 in the presence of two witnesses namely, Ms. Nikita Pncha and Mr. Pratham Kothari who are not in the employment of the Company.
- 7. The votes cast by the Members through remote e-voting were reconciled with the Register of Members / Register of Beneficial Owners of the Company as on the cut-off date.
