Mr. Balgopal Mandelia was unanimously elected as the Chairman of the Annual General Meeting, took the chair and conducted the proceedings of the Meeting as the requisite quorum was present. Thereafter, he introduced his colleagues on the Board of Directors of the Company who were present on the dais. The Chairman addressed the shareholders and spoke about Financial Performance of the Company, current economic situations and its impact.

The Chairman thereafter declared that the copies of audited financial statements for the year ended March 31, 2019, Director's and Auditors' report had been posted/mailed as the case may be along with Notice of the aforesaid Annual General Meeting to all the Members and that the original documents along with the statutory registers and Secretarial Auditors' Report were available for inspection. Further, with the consent of the Shareholders, the Notice convening the Meeting and the Auditor's Report were taken as read.

Mr. Balgopal Mandelia, Chairman of the Annual General Meeting read out and explained the qualifications contained in Secretarial Auditors Report.

The Chairman further informed the shareholders that e-voting facility has been provided to all Members to vote electronically and the company has also arranged for voting through ballot paper in the meeting on all the resolutions to be passed at the meeting for those members who have not cast their vote through e-voting and that there will be no voting by show of hands at the meeting. Clarifications were provided to the queries raised by the members.






