I have conducted the review of the compliance of the applicable statutory provisions and the adherence to good corporate practices by **Kalpataru Projects International Limited (formerly known as Kalpataru Power Transmission Limited)** (hereinafter referred as 'the listed entity'), having its Registered Office at Plot 101, Part - III, GIDC Estate, Sector - 28, Gandhinagar, Gujarat-382028. 
