## Dear Sirs,

We write this to your good office to humbly seek extension of time till 31st August,2020 for submission of the aforesaid financial results for the year ended 31st March, 2020 on the following grounds:

1.ln view of surge in number of COVID-19 cases in Chennai, there was complete lockdown in Chennai from 19th June, 2020 to 5th July, 2020. As a consequence of the above, our auditor was unable to visit our office at Bangalore and corporate office at Kolkata. However some restrictions are still continuing.
