गौरेश माळशेकर हा तरुण अंजुणे धरण प्रकल्पात या ठिकाणी गेल्या अनेक वर्षांपासून कार्यरत होता. शांत स्वभावाचा म्हणून त्याची विशिष्ट अशी ओळख होती. काल सकाळी त्यांनी आपल्या राहत्या घरात खोलीतच गळफास घेऊन आत्महत्या करण्याचा प्रकार घडला. गौरेश सकाळी लवकर न उठल्यामुळे त्याच्या आईने चौकशी करून दार उघडण्याचा प्रयत्न केला असता दाराला आतून कडी असल्याचे स्पष्ट झाले. शेवटी शेजाऱ्यांना बोलावून घराची काले काढून खोलीमध्ये पाहिले असता गौरेश गळफास लावलेल्या स्थितीत असल्याचा दृष्टीस पडला. या संदर्भाची माहिती वाळपई

पोलीस

स्थानकात देण्यात आली. पोलीस निरीक्षक दिनेश गडेकर यांनी घटनास्थळी भेट देऊन घटनेचा पंचनामा केला व मुतदेह उत्तरीय तपासणीसाठी गोमेकांत दरम्यान पोलीस निरीक्षक दिनेश गडेकर यांच्यासोबत साधला असता गौरेश यांनी गळफास घेऊन आत्महत्या केल्याचे स्पष्ट झाले. मात्र आत्महत्या करण्यामागचे कारण अजूनपर्यंत स्पष्ट झालेले नाही, असे यावेळी त्यांनी सांगितले. दरम्यान उत्तरीय तपासणीसाठी गौरेश याचा मुतदेह नात्याईकांच्या ताब्यात देण्यात आल्यानंतर त्याच्यावर अंत्यसंस्कार करण्यात आले. वाळपई पोलीस निरीक्षक दिनेश गडेकर या संदर्भात पुढील तपास करीत आहेत. एकूण या संदर्भात मिळालेल्या अधिक माहितीनुसार गौरेश गेल्या अनेक वर्षांपासून अंजुणे धरण

प्रकल्पामध्ये

अभियंता म्हणून कार्यरत होता. तो अविवाहित असून काही दिवसांनीच तो लग्नाच्या बंधनामध्ये अडकणार होता. दरम्यान हुशार, सुशिक्षित व शांत स्वभावाच्या तरुणाने गळफास घेऊन आत्महत्या करण्यामागचे कारण काय असेल, असा प्रश्न उपस्थित होत आहे. या घटनेमुळे खोतोडा गावावर शोककळा पसरली असून दुःख व्यक्त करण्यात येत आहे. गौरेश हा अत्यंत साधा व सोप्या स्वभावाचा तरुण होता. गावच्या सामाजिक व सांस्कृतिक विकासासाठी त्याचे महत्त्वाचे योगदान होते.
