4. Please check if any unclaimed dividends in your records and credit the said unclaimed dividends in my bank account as per ISR-2 enclosed.

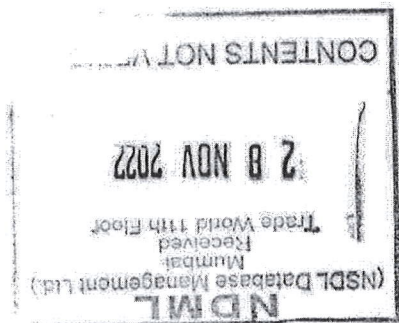
