Temporary disruption of operations at Sahapuram Plant**

Dear Sirs/Madam,

Pursuant to the requirement of Regulation 30(4) read with Para B of Part A of Schedule III to the SEBI (LODR) Regulations, 2015 and other applicable provisions, if any, we would like to inform that the Company's plant located at Sahapuram, Tamilnadu has been temporarily shut down from Wednesday, July 19, 2023 due to unexpected failure in the power plant at site. The expected time period of the shutdown will be around 5 to 6 days, however, the Management is making all possible efforts to bring this to normalcy as soon as possible.

During the aforesaid period, the Company will continue to service its key customers from the inventory of finished goods.

We would keep the stock exchange and all our stakeholders updated on any significant developments going forward and shall also keep informed as soon as the plant becomes operational.

Further in terms of SEBI circular CIR/CFD/CMD/4/2015 dated September 9, 2015 read with Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulation, 2015 the additional information required is given in the Annexure - I.
