The voting period for remote e-voting commenced on Saturday, February 19, 2022 at 09:00 a.m. (IST) and ended on Sunday, March 20, 2022 at 05:00 p.m. (IST) and the Central Depository Services (India) Limited e-voting module was disabled thereafter.

The votes cast under remote e-voting facility were thereafter unblocked.
