Parliament clears law to block no-deal Brexit

The British parliament's upper chamber on Friday approved a Bill which aims to block a no-deal Brexit at the end of October by forcing Prime Minister Boris Johnson to seek a delay to Britain's European Union departure.

The legislation, which requires Johnson to ask for a three-month extension to Britain's EU membership if parliament has not approved either a deal or consented to leaving without agreement by October 19, is expected to be signed into law by Queen Elizabeth on Monday. Johnson has dubbed it the "surrender bill" and said it has scuppered his Brexit negotiations with the EU by removing the threat of leaving without a deal.

Zimbabwe ex prez Mugabe dies at 95

Robert Mugabe, who led Zimbabwe with an iron fist from 1980 to 2017, has died aged 95, the country's president announced Friday. First heralded as a liberator who rid the former British colony of Rhodesia of white minority rule, Mugabe used repression and fear to hold on to power in Zimbabwe until he was finally ousted by his previously loyal military generals. "It is with the utmost sadness that I announce the passing on of Zimbabwe's founding father and former President... Robert Mugabe," Emmerson Mnangagwa said in a tweet.
