Dear Sir/Madam,

With reference to the captioned subject, please find enclosed herewith the disclosure under Regulation 29(2) of SEBI (SAST) Regulation, 2011 containing details of Disposition of Shares of AU Small Finance Bank Ltd (“AU Bank”).

Please note that on April 17, 2024 the total voting rights in AU Bank were 669,162,451. Wasatch Advisors LP (“Wasatch”) held 38,168,501 shares which totaled 5.70% of the total voting rights.

On April 18, 2024, due to actions taken by AU Bank, the total voting rights in AU Bank increased to 742,687,803. On the same day Wasatch also sold 50,502 shares of AU Bank. So as of April 18, 2024 Wasatch held 38,117,999 shares which represented 5.13% of the new total voting rights.

Wasatch is making this filing since its ownership in AU Bank has decreased by more than 2% since its last filing. However, we note that the majority of this decrease was not a result of the sales transaction but instead occurred due to AU Bank’s increase in total voting rights.
