- 1. Consequent upon the lockdown announced by the Central and State Governments, we stopped our production activities with effect from 6.00 pm 24th March 2020. This was also intimated to the Stock Exchange vide our letters dated 24th March, 2020.
- 2. We had also intimated the Exchange about the closure of Trading Window for the designated Insiders of the Company with effect from 1st April 2020.
- 3. The share price as on 24th March, 2020 was Rs. 17.95 and it was Rs. 19.50 on 31st March, 2020. The price as on 4th June, 2020 was Rs.26.85 per share.
- 4. We wish to inform you that during this interim period, when there was no production, no material events have taken place so as to have a bearing on the financial results of the Company/ any price sensitive information.
- 5. Consequent upon the extension of the lockdown, the Board will decide in due course the date of holding the Board Meeting to consider the Annual Accounts for the Financial year 2019-20.
- 6. The fluctuation of the stock prices on the Exchange has no bearing whatsoever on any sensitive information and it is purely based on demand and supply by investors other than the designated insiders, who have not participated in the trading at all.
