### PROCEEDINGS OF 39TH ANNUAL GENERAL MEETING OF JETKING INFOTRAIN LIMITED

The 39<sup>th</sup> Annual General Meeting ("the Meeting or AGM") of the Members of Jetking Infotrain Limited ("the Company") was held on Thursday, the 21<sup>st</sup> day of September, 2023 through Video Conferencing ("VC")/Other Audio-Visual Means ("OAVM"). The Meeting Commenced at 11:30 a.m. and concluded at 12:10 p.m.

In compliance with the applicable provisions, the Company had also provided two-way Video-Conferencing facility.

Mr. Suresh Bharwani, Chairman and Non-Executive Director of the Company, Chaired the proceedings of the 39<sup>th</sup> AGM of the Company.

Mr. Anand Mukherjee, Partner of AVS & Associates, Practicing Company Secretaries, Secretarial Auditor of the Company & Scrutinizer of 39<sup>th</sup> AGM had joined the meeting through VC.

### Proceedings in Brief:

Mr. Suresh Bharwani – Chairman and Non- Executive Director, took the Chair of the Meeting. He welcomed all the Directors and Shareholders of the Company to the 39<sup>th</sup> AGM. He then introduced the Directors on the Board and other representatives one by one.

The requisite quorum being present, the Chairman called the Meeting to order.

The Chairman informed the members that the Company had taken all feasible efforts to enable members to participate through video conference and vote at the AGM.

The Chairman then requested Mr. Deepesh Shah, Company Secretary & Compliance Officer of the Company to explain the procedural and technical aspect to the shareholders for attending the meeting. Mr. Deepesh Shah then explained the same to the members.

The Notice convening the AGM and the Annual Report of the Company for the financial year ended 31<sup>st</sup> March, 2023 along with Statutory Audit and Secretarial Audit Reports were taken as read as the same were already circulated to the members.

The Members were informed that the Company has made arrangements to enable the Members to vote electronically on the Resolutions placed before the Meeting and the e-voting had commenced on Monday, 18<sup>th</sup> September, 2023 at 09:00 am and had concluded on Wednesday, 20<sup>th</sup> September, 2023 at 05:00 pm.

The Company Secretary informed the members that MOA, AOA and the Statutory Registers as required under the provisions of the Companies Act, 2013, are made available electronically for inspection by the Members during the AGM. Members seeking to inspect such documents can send their request to <u>cs@jetking.com</u>.

The members were informed about the items of business proposed to be transacted at the Annual General Meeting. The following items of business as set out in the Notice convening the 39<sup>th</sup> AGM were recommended for Members consideration and approval.

The Chairman thereafter delivered a short speech and requested Mr. Siddarth Bharwani, Whole Time Director and Chief Financial Officer of the Company to give brief highlights on the Company performance. Thereafter, Mr. Avinash Bharwani, Whole Time Director of the Company gave an operational Highlights of the Company and some insights on the future plans of the Organization.

The Company Secretary thereafter welcomed the members who had registered themselves as speakers to express their views and ask questions or seek clarifications.

After that, Mr. Deepesh Shah then informed the members about the following:

- a) E-voting on the NSDL platform would continue for another 15 minutes to enable the members to cast their votes who have not casted their votes through remote e-voting.
- b) Mr. Anand Mukherjee, Practicing Company Secretary appointed as a Scrutinizer for scrutiny of the votes cast through the remote e-voting platform and electronic voting at the AGM.
- c) E-voting results along with the consolidated Scrutinizer's Report would be announced within two working days of conclusion of the AGM and the same would be intimated to the Stock Exchanges and also be uploaded on the website of the Company and NSDL.



The Chairman thanked the Members for joining the 39<sup>th</sup> AGM of the Company and declared the Meeting as concluded. The meeting concluded at 12.10 p.m.
