New Zealand's flurry of sixes demolishes England

It was bit of whirl, happy to get job done: Mitchell

Abu Dhabi, Nov 11: New Zealand opener Daryl Mitchell said he "couldn't remember" what was happening in the field of play as he went about scripting his team's sensational win over England in the first semifinal of the T20 World Cup here on Wednesday.

Player of the Match Mitchell blazed his way to an unbeaten 47-ball 72 to play a pivotal role in the five-wicket victory that seemed unlikely before a flurry of sixes from James Neesham and the opener himself brought the equation down to 20 in the last two overs.

Mitchell, though, finished the job with an over to spare with two sixes and a four in the penultimate over.

"It was a bit of a whirl at the end there. I couldn't remember what was going on, but I'm happy I got the job done," Mitchell said at the presentation ceremony.

"It was a challenging surface, with the new ball, and it was two-paced. The way (Devon) Conway set the platform and Neesh hit a few out of the ground was amazing. We knew one or two good overs would do it, and we got the momentum back thanks to Neesham's hitting.

"With what's going on around the world right now, it's amazing that my old man (his father) travelled half way around the world to watch me play, so this is a proud moment." In the game, Conway made an invaluable 46, and alongside Mitchell, played a part in keeping the Kiwis in the game.

Winning captain Kane Williamson said keeping wickets in hand was the key to his team's stunning win. "Outstanding from Mitchell at the top, but cashing in on the match-ups (was crucial). His character stood out today, an incredible knock, not done it a lot at the top of the order.

"T20 cricket is a game of small margins, depending on the surface, short side... can all be match-defining. We had wickets in hand which was really important. Neesham came out and hit the ball hard, and changed the momentum of the game. Ultimately the deciding factor," the Kiwi skipper said.

England skipper Eoin Morgan had no qualms in admitting that his team was outplayed by the Kiwis.

"Full credit to Kane and his team, they outplayed us today, I can't fault anything that we've done tonight, we've fought hard and represented ourselves well, but come up short tonight," Morgan said.

FMSCI rally season to begin in Vizag next month

Coimbatore set to host 3rd round; MMSC gets finale

Visakhapatnam, Nov 11: The 2021-22 season of FMSCI Indian National Rally Championship is set to begin here next month after being hampered by the COVID-19 pandemic. After a couple of postponements due to the pandemic, the premier motorsport event is scheduled to be organised here from December 16 to 18.

While the promoter wanted to go all out and have a full calendar, due to paucity of time and delays, there will be only four rounds this year, with the Round 3 happening in Coimbatore and conducted

by Coimbatore Auto Sports Club in February. MMSC has been awarded the right to organise the grand finale which will take place in March. The venue for the finale is yet to be decided.

The announcement was made by Sports Minister of Andhra Pradesh, Muttamseti Srinivas Rao, and the promoter of INRC, Vamsi Merla, on Wednesday.

This is the first time that the city will host a motorsport rally of such magnitude and the promoter as well as the government has promised to make it a grand affair.

The event will be conducted by the Karnataka Motorsport Club and apart from round 1, they have been given the responsibility to take care of the K100 Rally as well, which is round 2 and will take place in Bengaluru in January.

"It is a matter of huge pride for me that I am able to take the sport to new places which has always been my vision. I have always wanted motorsport to reach every nook and corner of the country. I would like to thank the Government of Andhra Pradesh for their support

and cooperation," Vamsi said in a statement. Apart from the championship rounds, a contender round is also being planned for April in Hyderabad.

The championship this year is expected to break all records in terms of participation and would see the involvement of major stakeholders of Indian motorsports including JK Tyre, MRF and Yokohama.

Provisional calendar: Round 1 - Visakhapatnam, December 16-18. Round 2 - Bengaluru, January 28-30. Round 3 - Coimbatore, February 26-28. Round 4 - MMSC, March 28-30.

All eyes on 'mother' Geeta as National Wrestling begins in UP

Gonda (Uttar Pradesh), Nov 11: A blockbuster clash between comeback girl Geeta Phogat and world champion Sarita Mor is keenly anticipated, while Narsingh Panchar Yadav and Gourav Balian will also be eager to prove themselves when the National Wrestling Championships begin here on Thursday.

Geeta, 32, is making a come back to the competitive wrestling after giving birth to her son, Arjun in 2018.

Set to compete in 59kg, the national event will help Geeta assert herself as she has a long term goal of competing in the 2024 Paris Olympics.

Much water has flown under the bridge since she stopped competing on the mat and it will be interesting to see how the 2010 Commonwealth Games gold medalist responds to the challenges ahead.

New rules are in place and the standard of Indian wrestling has also improved in the last few years.

But she has got a good start as save the close semifinal, Geeta easily cleared the state trials where she beat four Haryana grapplers to emerge the winner.

"My confidence got a good boost at state trials. I am pretty excited for the Nationals. It feels like a new beginning," Geeta told PTI.

Her biggest competitor would be Sarita, who last month won a bronze at the Oslo Worlds, where she beat defending world champion Linda Morais en route the bronze play-off.

Notwithstanding the world championship success, Sarita still finds the national championships exciting.

"Since childhood we target playing the Nationals because from here the avenues open up for all of us. It still excites me to compete with the best wrestlers in the country," Sarita told PTI.

Geeta praised Sarita for her steady progress. "I know she will be my main competitor. She is also two-time Asian champion but I know her game. She really fights hard. It will be an exciting clash, if it happens with Sarita. I am ready for it," said Geeta.

Sangeeta Phogat, who married Olympic bronze medallist Bajrang Punia, also made a comeback recently after an injury and exceeded everyone's expectation, including her own, when she won the world championship trials. Young Sonam Malik is still not fit enough to make a comeback after undergoing an elbow surgery and she will be missed in 62kg category competition.

Also missing from action will be world championship silver medal winner Anshu Malik and struggling star Vinesh Phogat as both are recovering from their respective injuries.

Sir,

It is heartening to note that the State Government on 11-09-2021 signed an MoU with DP world for proposed investment of Rs.2000 crore.

The MoU was signed in presence of Chief Minister M.K.Stalin and officials of D.P.World, Thangam Tennarasu, Irai Anbu Chief Secretary, Industries Secretary N.Muruganandam, Pooja Kulkarni, CEO Guidance Tamil Nadu and Senior Officials from the State Government were present on the occasion.

Global port operator DP World has signed a facilitation memorandum of understanding (MoU) with the Tamil Nadu Government for a slew of projects it is establishing in the State at an investment of Rs. 2000 crore.

DP World signed an MoU in UAE with the Tamil Nadu Government in September 2019 to invest Rs. 1000 cr in establishing a free trade warehousing zone (FTWZ) and subsequently, integrated Chennai Business Park (KBP) in Vallur, Ponneri Taluk, Tiruvallur district was established over an area of 125 acres. DP world's FTWZ was inaugurated on July 20, 2021. It is gathered that DP World is now proposing to invest about Rs. 2000 cr establishing a container Terminal, cold storage and sea food processing zone and free trade zone with an integrated rail siding, minor port in the Eastern Coast of Tamil Nadu and ICDs in Erode, Karur and Tiruppur. These projects are expected to create employment opportunities for 4500 people (1500 direct and 3000 indirect. With an investment of more than \$1.2 bn) Dubai based DP world is operating six terminals in India at major ports with a capacity of over 6mn TEUs.
