Dear Sir

As I may have informed earlier, my father, Madipalli Sree Krishna Murthy passed away on Nov. 28, 2016 and my mother, Madipalli Chandravathi passed away on February 17, 2017. Since their death, our home in Bhimavaram (20-1-22 Marellavari Street, Bhimavaram -534201) has been unoccupied. We recently noticed that there may have been a burglary, and many items, including share certificates, may have been stolen.

Our records indicate that my father, Late Madipalli Sree Krishna Murthy owned 100 shares in Bosch under Folio M02258. To the best of our knowledge, he did not dispose or transfer these shares. We are trying to determine the current status of these shares. If the shares were disposed/transferred after Nov. 2016, chances are the transfer/sale is not legitimate and may involve a criminal act.

We request your assistance in determining:

1. If the shares are still remaining in the Folio under the same name. If that is true, we will try to obtain a succession certificate, if that is possible without an original share certificate. Any advice on our pursuit of the same will be appreciated.
2. If the shares have been disposed/transferred after November 2016, please advise us on the date of such transaction and the name of the transferee so that we can determine potential action on stolen certificates. This will help us determine parties responsible.
