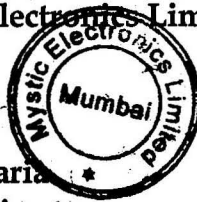

China's Yuan steadies but stocks plunge as trade tensions grow

Shanghai/Hong Kong: China's tumbling yuan steadied on Tuesday as authorities took steps to contain its slide while stocks plunged after Washington labelled Beijing a currency manipulator, marking a sharp escalation in U.S. trade tensions. The currency has slumped 2.3% over the past three days and broken past the symbolic 7-per-dollar level, pounding stocks and pushing bonds higher as investors feared the yuan's value has become a new front in the U.S.-China trade war. On Monday, U.S. Treasury Secretary Steven Mnuchin said Washington would designate China a currency manipulator, its first such move since 1994, sending both the onshore and offshore yuan to record lows. The People's Bank of China's firmer-than-expected yuan fixing on Tuesday helped pull the currency away from these lows as did an announced bond sale in the offshore market, seen as signs authorities wanted to stem the rout.

"(China is) seizing the narrative on the renminbi," said Andy Wong, multi-asset senior investment manager at Pictet Asset Management in Hong Kong.

"Rather than being pressured to signal that



7 is just a psychological level, they are... saying this is something that we control rather than markets or whatever other pressures." The yuan dropped to the record low in offshore trade early in Asia, after Mnuchin's announcement, before bouncing to steady around 7.0642 per The PBOC fixed the yuan midpoint, which sets the point around which the currency is allowed to trade, at 6.9683 per dollar, firmer than market expectations. The PBOC's announcement of a sale of 30 billion yuan (\$4.25 billion) worth of yuan-denominated bills in Hong Kong also suggested the central bank was soaking up cash to prevent speculative short-selling. The currency opened onshore trade at 7.0699 per dollar, then firmed to 7.0515 by 0310 GMT. The offshore

yuan fell to as low as 7.1397 per dollar before coming back as far as 7.0596. However, the currency's stabilisation on Tuesday was not enough to assuage markets, but did halt their slide by midsession. The Shanghai Composite Index fell over 2% to 2,733.92, touching its lowest level since February, while Hong Kong's Hang Seng Index hit its lowest since January before preparing some of the losses. "Renminbi weakening pressure added uncertainty to the stock market and added pressure especially for financials and property companies," said Linus Yip, chief strategist at First Shanghai Securities in Hong Kong.

"The PBOC is sending signals that it would like to mitigate RMB depreciation - by fixing dollar/yuan somewhat low, and by announcing to issue offshore bills," said Frances Cheung, a strategist at Westpac.

Chinese policy sources had told Reuters that the currency was allowed to slide so markets could factor in concerns over the tussle between the world's two largest economies, especially after President Donald Trump announced new tariffs last week."

HGS Q1 profit at Rs 40.4 cr, expects strong topline growth in FY'20

New Delhi, Hinduja Global Solutions (HGS) saw its consolidated net profit expand marginally to Rs 40.4 crore for the quarter ended June 2019 from the year-ago period. The company had registered a net profit of Rs 40.3 crore in April-June, 2018, HGS said in a filing on Monday night. HGS' revenue from operations grew 17.2 per cent to Rs 1,290.5 crore in the quarter under review as against Rs 1,100.8 crore in the year-ago period. Revenue growth in constant currency terms was 15.3 per cent. "PAT (profit after tax) was flat in the quarter, primarily due to drop in Other Income arising out of adverse exchange rate fluctuations," HGS CEO Partha DeSarkar said. He added that HGS' growth momentum continues in the new fiscal and the topline has grown 17.2 per cent, while EBITDA more than doubled in the quarter under review. "Growth was led by organic expansion and new client ramp-up, especially in the US... Based on the visibility from new wins and a healthy pipeline, we expect to post strong topline growth in the rest of year," he added. DeSarkar said all the geographies are performing as expected, and AxisPoint Health and India domestic businesses continue to show improvement for the company. "Our solutions for social care, intelligent automation, analytics and cloud services are seeing big demand from clients. We will increase our investments to build capabilities in these growth areas as we see big opportunities for technology-led services," he noted. At the end of June quarter, HGS had 241 core BPM clients and 668 HRO/Payroll processing clients.

राज्यातील पुरस्थितीवर बोलताना वडेटीवार म्हणाले की, मागील काही दिवसांपासून मुसळधार पाऊस पडत आहे. मुंबई शहर, परिसर तसेच ठाणे जिल्हा, सांगली, सातारा, कोल्हापूर, नाशिक, कोकणासह नगर जिल्ह्यातही सर्वदूर पाऊस झाला आहे. या भागातील नद्यांनी धोक्याची पातळी ओलांडली असून नदीकाठावरील घरे, वाहने, दुकानातील

साहित्यांचे मोठ्या प्रमाणात नुकसान झाले आहे. नदीकाठच्या शहरातील गृहसंकुलातही पाणी शिस्सू नुकसान झाले आहे. या पुरामुळे खरिप हंगार पाणी फेरले आहे. कापूस, मका, तूर, तांदूळ, उस, भूईमूग, घेवडा, सोयाबीन या शेतमालाचे कोट्यवधी रुपयांचे नुकसान झाले आहे. पाण्याचा निचरा न झाल्यामुळे हजारो हेक्टरवरची पीके पिळगी पडू लागली आहेत. अनेक शेतकर्यांनी खरिपासाठी कर्ज काढून बी-बियाणं, खताची खरेदी केलेली पण मुसळधार पावसाचा मोठा फटका बसल्याने शेतकरी पुरता हवालदिल झाला आहे.

कोयना, कृष्णा, वारणा, पंचांगा या नद्यांना आलेल्या पुरात नदीकाठच्या हजारो घरांना, पिकांना जलसमाधी मिळालेली आहे. पुराचा फटका बसलेल्यांच्या स्थलांतराबरोबर व्यापारी पेठांमधील साहित्यही हलवण्यात आले आहे. कोकणात मुसळधार पावसामुळे झाडांची पडझड झाली तसेच शेतीचेही मोठ्या प्रमाणात नुकसान झाले आहे. काही भागात पुराच्या पाण्यात जनावरे वाहून गेली आहेत तसेच काही ठिकाणी
