# Sub: Receipt of Arbitration award in Dhule Palesner Tollway Limited ("DPTL"), a subsidiary of the Company.

### **Ref:** Our earlier Letter vide Ref: SIPL/2019-20/0038 dated 1<sup>st</sup> August, 2019.

With reference to above subject and pursuant to the Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, read together with the circulars and notifications issued thereunder ("Listing Regulations") and with reference to our earlier announcement dated 1<sup>st</sup> August, 2019 regarding winning of an Arbitration Award against National Highways Authority of India (NHAI) by Dhule Palesner Tollway Limited (DPTL), a subsidiary of the Company, we are pleased to inform you that, NHAI has accepted arbitration award amounting to Rs.43,95,14,565/- without any pendente-lite interest and interest on delayed payment. Accordingly, sum of Rs. 43,29,21,847/- has been released by NHAI.

As per Restated Share Purchase Agreement ("RSPA") entered into on 28th October 2015, 60% of the awarded amount (net of taxes and expenses) shall be paid to HCC Concessions Limited and 40% belongs to the Company.

### About DPTL

Dhule Palesner Tollway Limited received appointed date on 21<sup>st</sup> December, 2009 to augment the existing road from Km. 168.500 to Km. 265.000 on the MP/Maharashtra Border – Dhule section of NH-3 in the state of Maharashtra by four-laning on DBFOT basis. Original concession period is 18 years from the Appointed Date. Total length of the project is 89.00 kms. DPTL achieved 1<sup>st</sup> CoD on 23<sup>rd</sup> January, 2012.

Further, also note that Company had signed definitive agreements with Indinfravit Trust on 1<sup>st</sup> July, 2019 to sell 100% stake in nine operational projects including DPTL and Company had transferred its stake of DPTL to IndInfravit Trust in February, 2020.
