Trump extends freeze on H-1B; IT firms to take hit

US President Donald Trump has extended the freeze on the most sought-after H-1B visas by Indian IT professionals, along with other types of foreign work visas and green cards through March 31 to protect American workers, saying that the reasons for which he had imposed such restrictions amidst the pandemic have not changed.

The freeze on various categories of work visas was ordered by Trump through two proclamations on April 22 and June 22 last year. Hours before the freeze was set to expire on December 31, Trump issued another proclamation on Thursday to extend it until March 31, ensuring that his sweeping limits on legal immigration will remain in place when President-elect Joe Biden is sworn in on January 20.

He said that the reasons for which he had issued such a restriction have not changed. The continuation of the restrictions, which comes with just 20 days left in the Republican President's term, is the latest effort to bar the entry of immigrants to the US.

Restricting immigration has been a focus of the Trump administration since its first days when it issued the travel ban on seven Muslim-majority countries, and it has continued into Trump's final year in office as the White House uses the coronavirus pandemic as cover.

Biden, a Democrat, has promised to lift the suspension on H-1B visas, saying Trump's immigration policies are cruel.

US media commented that Trump's decision was yet another example of how the his administration is trying to box Biden in on challenging policy matters.

The H-1B visa is a non-immigrant visa that allows US companies to employ foreign workers in specialty occupations that

require theoretical or technical expertise. The technology companies depend on it to hire tens of thousands of employees each year from countries like India and China. They would now have to wait at least till the end of March before approaching the US diplomatic missions to get stamping. It would also impact a large number of Indian IT professionals who are seeking renewal of their H-1B visas.

President Trump said the effects of Covid-19 on the US labour market and the health of American communities are a matter of ongoing national concern, and the considerations present in the two previous proclamations have not been eliminated.

"The 2019 Novel Coronavirus continues to significantly disrupt Americans' livelihoods. While the November overall unemployment rate in the US of 6.7 per cent reflects a marked decline from its April high, there were still 9,834,000 fewer seasonally adjusted nonfarm jobs in November than in February of 2020," Trump said in his proclamation.

The current number of new daily cases worldwide reported by the WHO, for example, is higher than the comparable number present during June, and while therapeutics and vaccines are recently available for an increasing number of Americans, their effect on the labour market and community health has not yet been fully realised, he said. "Moreover, actions such as States' continued imposition of restrictions on businesses still affect the number of workers that can be hired as compared with February of 2020," Trump said, adding that his latest proclamation may be extended if needed.

AUDI A4 SEDAN

The Audi A4, which has been absent from the Indian market for the last year, will finally re-launch as a fifth generation sedan that is sportier and more cutting-edge, design-wise. It is fully connected and has a new, two-litre engine generating power of 190 hp and speed of 0-100kph in 7.3 seconds. The A4 should also give a fillip to Audi whose sales volumes have been lagging in the last couple of years because of a shortage of products in the pipeline. Expected sticker price: ₹45 lakh.

M&M, Ford scrap joint venture plan

These developments are also an indication of the far-reaching implications of the Covid-19 pandemic and its impact on the business plans of companies in India and globally.

"Both companies were clear that terminating deal was a prudent decision in the current situation," said Pawan Goenka, managing director and CEO, M&M, alluding to the termination of the JV with Ford. This will also mark a change in tack for the company's priorities. "We won't build an international presence in the short term," he said at a press meet on Friday.

Elaborating the decision, Anish Shah, group chief financial officer and deputy managing director, M&M, said the JV didn't make sense because of a higher-than-anticipated investment. It would have been more than ₹1,400 crore, he said, "had we gone ahead with the investment based on the demand that we have seen."

The decision by the com-

panies ended a deal that was reached more than a year ago.

As part of the plan, Ford was expected to fold its local operations, including two factories, into a JV with Mahindra having majority control. Ford was to cede most of its Indian operations to Mahindra as part of the proposed agreement.

Under the new terms, Ford will continue its standalone business in the country.

As a next step, over the next 2-3 months, M&M and Ford will review each project that they had agreed to collaborate on, including supplies of engines to Ford by Mahindra and co-development of models.

"The final decision will be based on the merit of each project," said Rajesh Jejurikar, executive director for auto and farm division, M&M. "We will focus of our resources and build a very strong brand and capability to deliver a high-quality top-notch SUV portfolio," he said, adding that the success of the new Thar has

given a lot of confidence to the company.

Meanwhile, M&M is in the final stages of getting a buyer on board for its ailing South Korean subsidiary SYMC.

"We may sign a term sheet for SYMC next week. The deal is more or less agreed. We will conclude it by February 28, if everything goes according to the plan," said Goenka. After the sale, Mahindra will hold less than 30 per cent equity in the maker of Rexton and Tivoli SUVs, said Goenka.

On December 22, the company's Korean subsidiary said it had commenced a rehabilitation procedure with the Seoul Bankruptcy Court. This was after the struggling automaker missed the December 14 deadline for the repayment of ₹480 crore (60 billion Korean Won) to JPMorgan Chase Bank in

South Korea. M&M said the size of impairment taken by it would be based on the nature of the deal signed.

The Mumbai-headquartered firm taken ₹680 crore in loans from foreign banks. But it is expecting the net liability to be much less should the need arise to revoke the guarantee. Shah told investors. In a scenario that the deal with the buyer doesn't go through and the company is liquidated, the bankers can recover the loan from SYMC's assets.

The company has a total liability of ₹1,930 crore in SsangYong — ₹980 crore in equity and ₹930 crore in terms of debt. M&M will cease to be a majority shareholder in SsangYong before the end of this financial year to meet the capital allocation targets, said Shah.

RInfra completes sale of DA Toll Road for ₹3,600 cr

Reliance Infrastructure (RInfra) on Friday announced the completion of sale of its 100 per cent stake in DA Toll Road to Cube Highways and Infrastructure III Pte for an enter-

prise value over ₹3,600 crore. The deal was announced in March 2019 with the signing of a definitive binding agreement between RInfra and Cube Highways and Infrastructure, and has now been completed with transfer of shares of the DA Toll Road and

receipt of sale consideration, said the company release.

Cube Highways and Infrastructure III Pte is a Singapore-based company formed by Global Infrastructure Fund — I Squared Capital and a wholly-owned subsidiary of the Abu Dhabi Investment

Authority. The total transaction value is over ₹3,600 crore and the entire sale proceeds are being utilised for debt reduction, said RInfra.

RInfra has reduced its total debt liabilities by 20 per cent from the deal proceeds.
