स्पाइसजेट ने कार्गो कारोबार में हिस्सेदारी बिचकी की प्रक्रिया शुरु की

भारत की दूसरी सबसे बड़ी प्राइवेट एयरलाइन स्पाइसजेट ने लॉजिस्टिक व्यवसाय अलग कर इसे अपनी सहायक इकाई स्पाइसएक्सप्रेस को सौंपने की प्रक्रिया शुरु कर दी है। मंगलवार को कंपनी ने इस प्रक्रिया को पूरा करने और पात्र संपत्तियों नियोजन (न्यूआयडी) के जरिये 2,500 करोड़ रुपये तक की पूंजी जुटाने के लिए अपने शेयरधारकों को मंजूरी मांगी। कंपनी इस संबंध में विभिन्न निजी इन्वेंचर्स के साथ बातचीत कर रही है, क्योंकि वह को जुटाने के लिए एंजलस्टिक इकाई में शेयर बेचना चाहती है। हालाँकि एयरलाइन के अधिकारियों ने चेन्नमैल में यह संकेत दिया था कि इस व्यवसाय को बेचने पर अरब डॉलर पर है, लेकिन मंगलवार को कंपनी ने खतब मूल्यकन के आधार पर यह मूल्यकन 2,55.77 करोड़ रुपये होने का अनुमान लगाया। स्पाइसजेट को योजना से अवगत होने में संकेत दिया है कि निवेशकों ने यह खच दर दिख है कि ये कारगो व्यवसाय में दिलचस्पी लेना चाहते हैं। इस घटनाक्रम से अवगत एबी व्हाइज ने बताया, 'संबंधित निवेशक कारगो और व्याज व्यवसायों को पूरी तरह अलग रखे जाने के पक्ष में हैं।' एयरलाइन ने कारगो इकाई के लिए नए एयर ऑपरेटर परमिट के लिए नागरिक उड्डयन मंत्रालय से भी संकेत किया है और व्याज व्यवसाय से अलग प्रबंधन भी तैयार करने पर भी जोर दिया है। हालाँकि सूत्रों का कहना है कि एयरलाइन को इसके लिए श्रधताओं समेत कई तरह की मंजूरीयों मिलनी होंगी। एयरलाइन ने कहा है कि उसे उम्माद में है कि स्पाइसएक्सप्रेस 1 अक्टूबर के आसपास व्यवसाय
