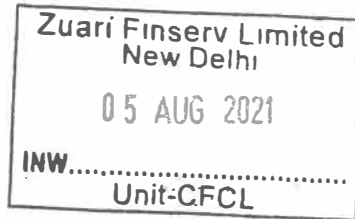

Also request you to please stop transfer of 2013-14 dividend to IEPF, as it is due for transfer to IEPF on October 19 2021.

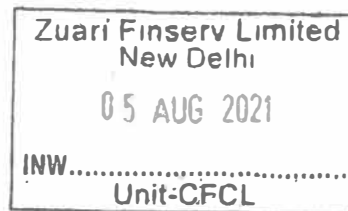
