- In accordance with the General Circular No. 20/2021 dated 08th December, 2021, issued by the Ministry of Corporate Affairs, Government of India ("MCA Circulars"), the physical copies of Postal Ballot Notice, along with Postal Ballot Forms and pre-paid business envelope, are not being sent to any members. Accordingly, the communication of the assent or dissent of the members eligible to vote is restricted only to remote e-Voting.
- 2. In accordance with the Circulars issued by the Ministry of Corporate Affairs, Notice of Postal Ballot is being sent through email only to those members, whose email addresses are registered with the company/Depositories and whose name appears in the register of members of the company or register of beneficial owners as maintained by the depository as on Friday, 26th May, 2023 ('Cut-Off Date').

Further, for those members whose email address is not registered with the depositories, the said Notice is also available on the website of the company https://www.rolexrings.com.

- 3. The company had engaged services of RTA to provide e-voting facility to its members. The Voting period commenced from 09:00 a.m. (IST) Tuesday,30th May, 2023 and end on at 5.00 p.m. (IST) Thursday, 29th June, 2023. The e-voting module was disabled by the Link Intime India Private Limited thereafter.
- 4. As confirmed by the Company, the company has issued a public Advertisement for notice to the members of the company in two Newspapers namely "Financial Express" an English Newspaper and Financial Express in local circulating Gujarati Newspaper in Gujarati Language as being the principal vernacular language of Gujarat having nationwide circulation on dated 30th May, 2023.
- The votes cast through electronic means received upto 5:00 pm (IST) on Thursday, 29th June, 2023 being last time and date fixed by the company for receipt of the votes cast through electronic means were considered for my scrutiny;
