The Board has also discussed the other operational, Financial and administrative matter in details and passed the necessary resolutions.

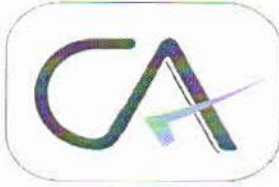


