The 10<sup>th</sup> Adjourned Annual General Meeting of the Company was held on Friday 7<sup>th</sup> October,2022 at 11.30 p.m. IST through Video Conference (VC) / Other Audio-Visual Means (OAVM).

Mr Ankit Kothari Chair the 10th Annual General Meeting.

As this was the adjourned AGM the members present in the meeting form the forum .The Chairman called the meeting to order after confirming the quorum for convening the valid Annual General Meeting under Section 103 of the Companies Act, 2013 was present.
