पुणे : लॉकडाउनमुळे डिजिटल व्यवहारांत मोठी वाढत होत असून, सायबर ठगांनी ऑनलाइन लूट मोठ्या प्रमाणात सुरू केली आहे. डेबिट, क्रेडिट कार्डांची माहिती चोरून त्याचे क्लोनिंग करणे. बँक खातेदारांशी संपर्क साधून त्यांना फसवून बँक खात्याची गोपनीय माहिती विचारून पैसे काढण्याच्या घटना वाढल्या आहेत. शहरात गेल्या सव्वा चार महिन्यांत साडेतेराशे डेबिट, क्रेडिट कार्ड फसवणुकीचे गुन्हे घडले असून, यात नागरिकांना कोट्यवधी रुपयांचा गंडा घातल्याचे समोर आले आहे. देशात डिजिटल व्यवहारांना सरकारकडून प्राधान्य दिले जात आहे. त्यामुळे मोठ्या प्रमाणात डिजिटल व्यवहार वाढले आहेत. नागरिकांकडून डेबिट, क्रेडिट कार्डचा (प्लास्टिक मनी) मोठ्या प्रमाणात वापर केला जाऊ लागला आहे. मात्र, डेबिट, क्रेडिट कार्डधारकांच्या अनभिज्ञ असण्याचा फायदा घेऊन त्यांना सायबर चोरटे सहज फसवू लागले आहेत. बँकेतून अधिकारी बोलत असल्याचे सांगून कार्डची माहिती चोरांकडून विचारली जाते. कार्डे बंद पडण्याची भीती दाखवून नागरिकांकडून

कार्डची सर्व माहिती विचारली जाते. काही वेळातच कार्डधारकांचे बँक खाते रिकामे झाल्याचा मेसेज आल्यानंतर फसवणक झाल्याचे त्यांना समजते. तोपर्यंत सायबर चोरट्यांनी सर्व पैसे काढून घेतलेले

डेबिट, क्रेडिट कार्डचे क्लोनिंग करूनही वेगवेगळ्या ठिकाणांहुन पैसे काढले जातात. बँकेचा डेबिट व क्रेडिट कार्डचा डेटाही 'हॅक' करून पैसे लुबाडले जात आहेत. गेल्या वर्षात पुणे शहरात डेबिट, क्रेडिट कार्ड फ्रॉडचे सहा हजार गुन्हे घडले होते. त्यात चार हजार ५०९ गुन्ह्यांत डेबिट, क्रेडिट कार्डचा वापर, तर डेबिट, क्रेडिट कार्डचा डेटा चोरून ९०९ गुन्हे केले होते. ओटीपी शेअर फ्रॉडचे ४९९ गुन्हे घडले होते. या वर्षी पहिल्या सव्वाचार महिन्यांत डेबिट, क्रेडिट कार्ड फ्रॉडचे साडेतेराशे गुन्हे घडले आहेत. यात डेबिट, क्रेडिटचा वापर करून ९९८ जणांची फसवणूक झाली आहे, तर कार्डांची माहिती चोरून १८२ गुन्हे घडले आहे.
