Govt to SC: ₹18k cr returned to banks

THE GOVERNMENT ON Wednesday informed the Supreme Court that around ₹18,000 crore has been returned to the banks in the cases relating to fugitive industrialists Vijay Mallya, Nirav Modi and Mehul Choksi, who are facing charges of loan frauds and money laundering.

THE PACE OF registration of unorganised workers on the government's e-Shram portal has fallen steadily - and rather steeply - since the peak levels achieved in December 2021, even as one in almost one in three of them are yet to find themselves on the portal.

With 8.2 crore registration, Uttar Pradesh tops the list among the states followed by Bihar (2.74 crore), West Bengal (2.51 crore), Madhya Pradesh (1.41 crore) and Odisha (1.32 crore). Agricultural sector rules the roost with 13.35 crore registration till now followed by domestic & household workers at 2.66 crore. Majority of the workers (24 crore) earn ₹10,000 or less in a month. Females have a higher share of registration at 52.73% than their male counterparts. Of the total registered, 62% are in the 18-40 years age bracket, 22% in the 40-50 years age bracket and the remaining above 50 years. Nearly 46% registered belong to the other backward class (OBC).

THE MINISTRY OF road transport and highways (MoRTH) has reinstated the provision of Earnest Money Deposit (EMD) for highway project bids, a move that will ensure only serious bidders take part in the bidding process.

At 1-1.5% of project cost, EMD is required to be submitted at the time of bid submission

"The decision to reinstate EMD will ensure only serious bidders take part. In the recent past, we have noticed the number of bidders for an EPC project going up to 40-45 compared with around 20 in normal situation. For HAM projects also, the number went up substantially," said Ica's Rajeshwar Burla.

cost, EMD is required to be submitted at the time of submission of bid. Sans the requirement of the EMD, withdrawn from November 2020 to provide relief to contractors facing acute cash crunch during the pandemic time, the numbers of bidders for a project sharply increased, much higher than usual. The trend of submitting very low bids has also been noticed for consultancy contracts as well in recent times.

SC: Employer obligated to pay damages for delay in EPF contribution

AN EMPLOYER IS under an obligation to pay the damages for delay in payment of the contribution of Employees' Provident Fund (EPF) of an employee, the Supreme Court said on Wednesday.

A bench of Justices Ajay Rastogi and Abhay S Oka said the EPF & Miscellaneous Provisions Act is legislation for providing social security to the employees working in any establishment and engaging 20 or more persons. The SC said it casts an obligation upon the employer to make the compulsory deposit in the PF and to deduction for workers' account in the EPF Office. — PTI
