## Sub: Intimation under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations")

This is in continuation to our letter no. APL/SEC/31/2022-23/02 dated 1<sup>st</sup> April, 2022, wherein it was, inter alia, informed that the Company has entered into a Shareholders Agreement and Share Subscription Agreement with the promoters of Weatherseal Fenestration Private Limited (hereinafter referred to as "Weatherseal Fenestration"), Mr. Harish Munireddy and Ms. Pratibha SB and Weatherseal Fenestration, inter alia, for infusion of Rs. 19 crores (approx.) for 51% stake by subscription to the equity share capital of Weatherseal Fenestration, subject to customary closing adjustments and conditions precedent.

It is informed that the Company has, today, subscribed to 51% of the equity share capital of Weatherseal Fenestration comprising of 10,409 equity shares of Rs. 10 (Rupees ten) each at a premium of Rs. 18.091 (Rupees eighteen thousand and ninety-one only) per share, issued on preferential basis for an aggregate cash consideration of Rs. 18,84,13,309 (Rupees eighteen crore eighty-four lakhs thirteen thousand three hundred and nine only).

Accordingly, Weatherseal Fenestration is now a subsidiary of the Company.

The disclosures in terms of Regulation 30 of the Listing Regulations read with SEBI Circular No. CIR/CFD/CMD/4/2015 dated 9th September, 2015 has already been provided vide our aforementioned letter dated 1<sup>st</sup> April, 2022.
