- 1. The above unaudited results have been reviewed by the Audit Committee and approved by the Board of Directors at their meeting on July 28, 2022.
2. Provisioning for IBNR / IBNER in the Revenue Accounts is based on the certificate from the Appointed Actuary of the Company.
3. The non - convertible debentures issued by the Company are rated "AA Stable" by both CRISIL and ICRA. Interest accrued on these debentures upto June 30, 2022 is ₹67.30 Lakhs. Due date of payment of next coupon interest on debentures is December 02, 2022 and principal repayment is due on June 2, 2032.
4. The Code on Wages, 2019 and the Code on Social Security, 2020 relating to employee benefits, during employment and post-employment, received Presidential assent on September 28, 2020.
