Consequent to classifying into GSM and failing in raising fresh capital for Internet Retail businessthe business, the company has suspended it's Internet Retail operation wef 1st April, 2017. The company is exploring various

opportnities and partnerships in order to revive its business activities and shall be coming up with its new business activities. In an case, it is continued to be a 'going concern'. Acquisition process of Citicycle India Pvt. Limited and making it as 100% subsidiary of the company as per the Memorandum of Understanding signed with them including its promoters has been cancelled as no substantial and milestone progress was made by them and the conditions precedent have not been complied with by them.

The scheme of financial rehabilitation including that of reduction in capital has been posponed for the time being in view of difference.
