business, thereby Siphoned off funds. Accordingly, the Identification Committee had issued order on 17.05.2022 In its said order the committee had also directed that the above named borrower/proprietor are free to make a written representation against the order of Identification Committee, within a period of 15 days from the date of receipt of order to the Review Committee headed by the MD 8 CEO of the Bank

ORDER OF THE REVIEW COMMITTEE FOR DECLARATION OF WILFUL **DEFAULTERS:**


