With reference to the captioned subject, this is to inform you that there is a delay in submission of Audited Financial Results of the Company for the quarter / year ended 31/03/2023.

We hereby inform you that the said delay is due to extraordinary event of commencement of the CIRP on 15.11.2022 resulting in change in management and additional time consumed in data collection and review than it was originally anticipated.

As submitted earlier due to commencement of CIRP there has been financial distress and huge dislocation in the management of day to day affairs of the company caused mainly due to non availability/ resignation of KMP/ and lack of concerned staff required to handle these specialised jobs.

Also, there is an undue delay by Statutory Auditors in completion of the audit for the Financial Year 2022-23. The financials will be submitted to the Exchanges once the audit is completed.
