Sub.: Intimation of allotment of Equity Shares upon conversion of Warrants on preferential basis under the provisions of the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018 (“SEBI ICDR Regulations”).

This is in furtherance of the intimation No. **RDL/089/2023-24** given by the Company on 23rd December, 2023, wherein we had informed you that the Company had allotted 41,30,000 convertible warrants to total 38 allottees on preferential basis for an issue price of Rs. 297/- per warrant, out of which **Rs. 30.66 Crores** (25% of the issue price) has already been received as the initial subscription amount at the time of allotment of the warrants.

The Company had allotted 1,90,000 equity shares by conversion of 1,90,000 warrants to 5 allottees (Non Promoters) from the total 38 allottees as intimation No. **RDL/013/2024-25** given by the Company on 9th May, 2024.

Out of remaining 75% amount, 2 allottees (Non Promoters) have deposited Rs. 1,44,78,750/- in aggregate towards their respective subscription and have exercised their right to convert total 65,000 warrants into 65,000 equity shares of the Company of face value Rs. 10/- each.

Pursuant to Regulation 30 read with Schedule III of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“**SEBI Listing Regulations**”), we wish to inform you that out of the balance 39,40,000 convertible warrants allotted, **2 allottees** as per the details given in **Annexure-B** attached, have now opted to exercise and convert the 65,000 warrants which are convertible into 65,000 equity shares of the Company, of face value Rs. 10/- each, in terms of the provisions of Chapter V of the SEBI ICDR Regulations, and the terms of allotment of the warrants.

In this regard, the Board of Directors of the Company has, at its meeting held on 24th May, 2024, considered and approved the allotment of 65,000 equity shares of the Company of face value of Rs. 10/- each, at a premium of Rs. 287/- per share, pursuant to the exercise and conversion of 65,000 convertible warrants (out of the balance 39,40,000 convertible warrants allotted) against receipt of the
