1) Resignation:

- a) Took on record the resignation of Mr. Subhas Chandra Bose from the position of Chief Financial Officer ("CFO") of the Company with effect from Thursday, December 15, 2022 (after the closing of business hours) due to personal reason. Subsequent to his resignation as CFO, he will also cease to be a Key Managerial Personnel ("KMP") under the provisions of Section 203 of Companies Act, 2013.
- b) Mr. Subhas Chandra Bose, has also confirmed that there is no other material reason for the resignation, other than, as stated above, and the same was noted by the Board. Enclosed herewith as "Annexure -A" is the brief details of change in Key Managerial Personnel as prescribed vide SEBI circular dated September 9, 2015.



2) Appointment:

On the recommendation of the Nomination and Remuneration Committee of the Company, the Board of Directors, at their meeting held today, i.e., on Tuesday, December 27, 2022 have approved the appointment of Mr. Naresh Parbat Sasanwar, as the Chief Financial Officer ("CFO") of the Company, with effect from December 27, 2022. Accordingly, as per the provisions of Section 203 of the Companies Act, 2013, he becomes the Key Managerial Personnel ("KMP") of the Company.


