This is in reference to the circular bearing No. SEBI/ HO/CFD/CMD1/CIR/ P/ 2020/84 dated 20th May 2020 issued by the Securities and Exchange Board of India.

Our nation is under lockdown due to COVID-19 pandemic since March 25, 2020 which has caused various difficulties in running the normal operations of the Company. However, effective work-from-home policies were implemented by the Company's management enabling the organization to render its activities on limited basis. As of today, in line with the various directives of the Government, the company continues its plant operations in the permitted manner.

Company is able to manage its capital and financial resources with the help extended by the bankers as per RBI directives for supporting businesses to mitigate the impact of Covid-19. Profitability is under stress but we hope it will revive soon once the Covid-19 Pandemic/Lockdown comes to an end. Company's assets are fully maintained.
