We had been re-appointed as statutory auditors of the Company, pursuant to the shareholder's resolution dated September 27, 2019 for term of 5 consecutive years commencing from the financial year 2019-20 to hold office from the conclusion of 17<sup>th</sup> Annual General Meeting till the conclusion of the 22<sup>nd</sup> Annual General Meeting of the Company. We had further been appointed to conduct the Limited Review for Quarter ended June'23, September'23 and December'23 vide your appointment letter dated June 05, 2023 and your agreeing to our terms of agreement vide Engagement Letter dated June 07, 2023.

Further to our various discussions with the management of Elin Electronics Limited ("Holding Company"), we understand that there has been a change in Holding Company's landscape owing to its status of a listed company and inclination of Holding Company's Management to appoint large audit firms as statutory auditors of the Company. Accordingly, we have agreed to step down and hereby convey our intention to resign as Statutory Auditors of the Company after the conclusion of the forthcoming Board Meeting to be held on August 10, 2023.

With references to our appointments referred in first para, we have completed the statutory audit of the company for the financial year ended March 31, 2023 and issued our audit report to board of directors of company on May 30, 2023. We are also in process of issuance of limited review report in respect of financial results of the company for the quarter ended June 30, 2023.

As per the requirement of the Companies Act, 2013, we shall be forwarding the copy of the ADT-3, as filed with ROC, in due course.
