We wish to inform that Mr.J.N.Karamchetti has confirmed that there is no other material reason for his resignation as Director of the Company, other than those cited above.

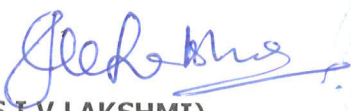

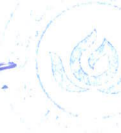
