This is to intimate that the ESOP Share Allotment Committee has passed a resolution by circulation today, i.e., on September 22, 2023 (around 02:00 p.m.), approving the allotment of 27,226 equity shares exercised under the 'Borosil Limited – Special Purpose Employee Stock Option Plan 2020' (ESOP 2020) and 45,658 equity shares exercised under the 'Borosil Limited – Employee Stock Option Scheme 2020' (NEW ESOS 2020).
