# अर्थसंकल्पाच्या पार्श्वभूमीवर शेअर बाजारात चढउतार!

नवी दिल्ली, दि. ३० ( वृत्तसंस्था ) : २०२३–२४ या आर्थिक वर्षासाठी केंद्रीय अर्थसंकल्प सादर होण्याच्या एक दिवस आधी, मंगळवारी सुरुवातीच्या व्यवहारात देशांतर्गत शेअर बाजारात मोठ्या प्रमाणात चढ उतार दिसून आला. व्यवहाराच्या शेवटी सेन्सेक्स-निफ्टी हिरव्या निशाणात बंद झाले. एनर्जी, इन्फ्रा, रिअल्टी निर्देशांक काठावर बंद झाले.

दुसरीकडे, आयटी, फार्मा समभागात विक्री दिसून आली. मिडकॅप, स्मॉलकॅप शेअर्समध्ये मोठी वाढ झाली आहे. व्यवहाराअंती सेन्सेक्स ४९.४९ अंकांच्या म्हणजेच ०.०८ टक्क्यांच्या वाढीसह ५९,५४९.९० वर बंद झाला. त्याच वेळी, निफ्टी ३३.३५ अंकांच्या किंवा ०.१९

टक्क्यांच्या वाढीसह १७,६८२.३० च्या पातळीवर बंद झाला. बाजाराच्या व्यवहारात बीपीसीएलच्या सरुवातीच्या शेअर्समध्ये तीन टक्क्यांची उसळी होती. अल्ट्राटेक सिमेंटचे शेअर्स सेन्सेक्समध्ये १.२८ टक्क्यांच्या वाढीसह सर्वाधिक

# BUOYED BY HIGHER REVENUE Coal India Q3 net soars over 70% to ₹7,719 cr

### MITHUN DASGUPTA Kolkata, January 31

BUOYED BY HIGHER revenue from operations due to higher realisation, state-run miner Coal India on Tuesday reported a 69.41% year-on-year rise in its net profit to ₹7,719.11 crore during the third quarter ended December 31, 2022.

The company had posted ₹4.556.54-crore net profit in the third quarter last fiscal. CIL's revenue from operations grew 23.69% y-o-y to ₹35,169.33 crore during the quarter under review from ₹28,433.50 crore in the corresponding period of FY22, according to a stock exchange filing.

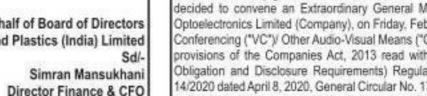
