अर्थसंकल्पाच्या पार्श्वभूमीवर शेअर बाजारात चढउतार!

नवी दिल्ली, दि. ३० (वृत्तसंस्था) : २०२३-२४ या आर्थिक वर्षासाठी केंद्रीय अर्थसंकल्प सादर होण्याच्या एक दिवस आधी, मंगळवारी सुरुवातीच्या व्यवहारात देशांतर्गत शेअर बाजारात मोठ्या प्रमाणात चढ उतार दिसून आला. व्यवहाराच्या शेवटी सेन्सेक्स-निफ्टी हिरेच्या निशाणात बंद झाले. पन्नाजी, इन्फ्रा, रिअल्टी निर्देशांक काठावर बंद झाले.



दुसरीकडे, आयटी, फार्मा समभागात विक्री दिसून आली. मिडकॅप, स्मॉलकॅप शेअर्समध्ये मोठे वाढ झाली आहे. व्यवहाराअंती सेन्सेक्स ४९.४९ अंकांच्या म्हणजेच ०.०८ टक्क्यांच्या वाढीसह ५९,५४९.९० वर बंद झाला. त्याच वेळी, निफ्टी ३३.३५ अंकांच्या किंवा ०.१९

टक्क्यांच्या वाढीसह १७,६८२.३० च्या पातळीवर बंद झाला. बाजाराच्या सुरुवातीच्या व्यवहारात बीपीसीएलच्या शेअर्समध्ये तीन टक्क्यांची उसळी होती. अल्ट्राटेक सिमेंटचे शेअर्स सेन्सेक्समध्ये १.२८ टक्क्यांच्या वाढीसह सर्वाधिक

BUOYED BY HIGHER REVENUE Coal India Q3 net soars over 70% to ₹7,719 cr

BUOYED BY HIGHER revenue from operations due to higher realisation, state-run miner Coal India on Tuesday reported a 69.41% year-on-year rise in its net profit to ₹7,719.11 crore during the third quarter ended December 31, 2022.

The company had posted ₹4,556.54-crore net profit in the third quarter last fiscal. CIL's revenue from operations grew 23.69% y-o-y to ₹35,169.33 crore during the quarter under review from ₹28,433.50 crore in the corresponding period of FY22, according to a stock exchange filing.

"The steep rise in profit came on the back of higher addition over the notified price in auction sale of 14.65 million tonne (MTs) coal during Q3 FY23," the coal miners said in a release. Though auction volumes were lower by 44% in Q3 FY23, compared to 26 MTs in the same quarter of FY22, higher premiums under the e-window helped CIL in ranking



up sales by ₹2,341 crore. "The realisation per tonne of coal was ₹5,046 under the auction segment in Q3 against ₹1,947 per tonne for comparable quarter in FY22. The jump was ₹3,099 per tonne or 159%," it added. The company said volume sale of 158 MT and better average realisation under the FSA resulted in a net impact of around ₹3,580 crore.

FSA sale increased by 13.2 MT in the Q3 FY23 compared to 144.6 MT of Q3 FY22. Realisation per tonne of coal under the FSA category was ₹1,482 in Q3 FY23, which was an increase of 8.2% compared to ₹1,370 per tonne of Q3 FY22.

The company's net sales during the third quarter this fiscal was up by 25% y-o-y to ₹32,429 crore compared to ₹25,991 crore of third quarter of last fiscal. Earnings before interest, tax, depreciation, amortisation (Ebitda) — the measure of a company's financial performance — rose 91% for the nine-month period to ₹31,998 crore from ₹16,769 crore in the same period in FY22.

IOC profit tumbles 92% to ₹448 cr

STATE-RUN OIL MARKETING company Indian Oil Corporation (IOCL) on Tuesday reported a net profit of ₹448 crore for the October-December period (Q3 FY23), a fall of 92% against ₹5,860.80 crore reported in the year-ago period.

The company returned to profitability after two consecutive quarters of losses. The profit in the Q3 FY23 was driven mainly by easing crude oil prices. Revenue from operations was up by 15% to ₹2.28 trillion from ₹1.97 trillion a year ago.
