Uttarakhand UCC draft ready, a likely template for Centre's legislation

THE EXPERT COMMITTEE for a Uniform Civil Code in Uttarakhand is all set to submit its report, along with a draft of the proposed law, to the state government by the end of July.

It is learnt that the Union government is expected to use it as a template for drafting its own UCC Bill and ruling party members hope to take it up in the winter session of Parliament.

On Friday, Justice Ranjana Prakash Desai, a former judge of the Supreme Court who heads the five-member expert committee, told the media: "It gives me immense pleasure to inform you that the drafting of the proposed Uniform Civil Code of Uttarakhand is now complete. The report of the expert committee along with the draft will be printed and submitted to the Government of Uttarakhand."

Sources said the draft Uttarakhand Bill, with an underlying theme of gender equality, will have provisions of equal rights for daughters and sons in property inheritance, equal duty of both to parents and equal grounds for adoption and divorce in all communities, cutting across religions. It will also have provisions that will make a declaration mandatory to start and terminate live-in relationships.

"Declaration will be mandatory for live-in relationships – to begin and terminate. This is to avoid both men and women getting cheated later," a source said. "Similarly, there were widespread demands for equal rights to both daughters and sons in inheriting properties as well as in children's duties

towards the parents," the source said.

Although the report has clear recommendations for a two-child norm in government jobs, in availing welfare schemes and government contracts, the committee is still to take a final decision on whether it should be part of the draft Bill.

Sources said the Uttarakhand expert committee looked at a Private Member's Bill moved in 2018 by BJP MP and present Union Minister Sanjeev Balyan. "Around 125 MPs had signed the Bill on Responsible Parenthood. It has provisions on two-child norms. It is a part of the report, but it has not yet been finalised if it should be part of the draft Bill," the source said.

Taking note of a strong demand from Muslim women, the draft Bill, sources said, will reject polygamy, iddat (the period a woman must observe after the death of her husband or after a divorce during which she may not marry another man) and halala (a practice in which a woman, after being divorced by triple talaq, marries another man, consummates the marriage, and gets divorced again in order to be able to remarry her former husband).

Although the panel received many suggestions on the rights of the LGBTQIA+, it is waiting for the Supreme Court verdict on same-sex marriage. The apex court has reserved its verdict on a batch of petitions seeking the right to marriage for members of the LGBTQIA+ community under the Special Marriage Act, 1954.

Unlike the Law Commission of India, which can advise the government on legal reform with its report, the Uttarak-

hand expert committee under Justice Desai has the mandate to oversee implementation of the UCC in the state.

"This means the committee, which has its term until September 26, can even form the rules once the state Assembly passes the legislation," a source said.

On June 14, the Law Commission of India sought public views on the UCC within 30 days.

Sources in the Uttarakhand committee, formed in May 2022, said that during its public interactions, the panel consulted around 2.5 lakh people, and most demands from the people, irrespective of community, were on "population control, ban on polygamy, increasing the marriage age of girls to 21, equal rights to properties and declaration of live-in relationships".

The panel's focus was on issues on which most communities expressed concern, sources said, and not taking a confrontational path.

Apart from religious groups, social organisations and different statutory commissions, the committee sought views from 10 political parties that contested the 2022 state elections. All parties barring the Congress, AAP and CPI gave their views to the panel, sources said.

The committee's wider consultation – 20 lakh households in a state with a population of 1.2 crore – appeared to have "inspired" the ruling BJP and the Central government to consider it as a template for the national UCC.

On June 2, while the Desai-led panel was in New Delhi, members of the Law Commission met them.

External debt at \$624.7 bn at March-end

INDIA'S EXTERNAL DEBT rose marginally to \$624.7 billion annually at end-March 2023, although the debt-GDP ratio declined, according to the Reserve Bank of India data released on Friday.

The external debt rose by \$5.6 billion to \$619.1 billion at end-March 2022.

"The external debt to GDP ratio declined to 18.9 per cent at end-March 2023 from 20 per cent at end-March 2022," said the Reserve Bank's data on India's External Debt as at end-March 2023. Valuation gains due to the appreciation of the US dollar compared to the Indian rupee and major currencies such as yen, SDR, and euro were placed at \$ 20.6 billion.

"Excluding the valuation effect, external debt would have increased by \$26.2 billion instead of \$5.6 billion at end-March 2023 over end-March 2022," the central bank added.

At end-March 2023, as per the data, long-term debt (with original maturity of above one year) was placed at \$496.3 billion, recording a decline of \$ 1.1 billion over its level at end-March 2022.

'One force, one area' strategy for better coordination in Manipur

FOLLOWING THURSDAY'S VIOLENCE in Manipur, which had seen two weeks of relative peace in between, the security establishment is re-strategising the deployment of forces in the fringe areas of the Imphal valley. It has now been decided to give responsibility of certain districts to one single force rather than deploying columns of various forces at different places in a district.

Given the frequency of violence in these troughs where the Valley meets the hills, the Manipur security establishment had decided to create buffer zones in these areas so that Valley people could be prevented from going towards the hills and vice versa. However, Thursday's incident on the Imphal West-Kangpokpi boundary that led to deaths of at least two civilians and some incidents of arson in the preceding days has exposed the inadequacy of the security arrangement.

Among the reasons analysed by the security establishment is lack of proper coordination among various forces and the vastness of the topography to be covered. While the

latter has little solution until more forces are pumped in, to resolve the issue of coordination, it has been decided to hand over responsibility of an entire district or more, depending upon the size of that force present in Manipur, to one force.

"This will strengthen the command and control structure as well as facilitate smooth logistics management. Say, if Bishnupur and Churachandpur districts are given to the BSF, it will alone be held responsible for lapses and thus will remain prompt. At the same time, it will be easier for the commanders to place and manage the forces on the

ground as there will be a single command structure for the entire area. Right now a lot of energy is going into coordinating alone," said a senior official.

Currently, there are close to 40,000 central force personnel present in Manipur. These include the Assam Rifles, the Indian Army, the BSF, the CRPF, the SSB and the ITBP. In any fringe area in a district, currently, a mix of all these forces is deployed. For example, if the Army is manning a fringe area in Moirang, just a few kilometres ahead at Torbung, it is the Assam Rifles. In between both BSF and CRPF deployment can be seen.

"Killings are happening

only when one side is going to the other with the intention of arson. The Hraohtel incident where two Meitei civilians died on Thursday happened when Kukis retaliated to a Meitei mob trying to burn their houses. The Meitei action itself is a result of some Kukis trying to burn Meitei houses in another area. It is a spiralling cycle which we are trying to break by maintaining a robust buffer zone," said another official.

Lack of trust between Kukis and Manipur Police and Meiteis and Assam Rifles has only added to the problem. This has also begun to reflect in depletion of trust among the forces itself. Sources in the security establishment said the Army, which was forced by a mob to release 12 Kanglei Yawol Kanna Lup (KYKL) insurgents arrested by it earlier this week at Itham village in Imphal East district, had not taken the Manipur DGP in loop before conducting the operation.

"This is not to say that the Manipur Police would have ensured they are not released. The division within the force is a reality. But maybe the operation could have been planned differently," said a home ministry official.

Shah slams Oppn, says 21 parties have come together to make Rahul prime minister

UNION HOME MINISTER Amit Shah on Friday attacked the opposition, accusing it of corruption and said 21 parties have come together to make Rahul Gandhi the Prime Minister.

"Opposition leaders gathered in Patna. All of them did a press conference on a big stage. I also saw the press conference. I am in politics for many years. I thought, who are these people who have gathered? They were from 21 parties and were those who do corruption of 21 lakhs," said Shah while addressing a public meeting in Udaipur on Friday.

Shah also challenged the opposition and said none of them could level a single accusation of corruption against the Modi government. "These 21 parties, those who do corruption of 21 lakhs, they have come together to make Rahul Baba the PM," he said.

Shah added that if Rahul Gandhi becomes the Prime

Minister, then corruption will become the country's destiny while if Modi becomes the PM again, then those who engage in corruption will go to jail.

"All these 20-21 parties, they don't think of your good but think of the future of their sons. I can say by names. The entire objective of Sonia ji's life

is to make Rahul ji the Prime Minister. Lalu ji's ambition is to make his son Tejashwi the PM. Mamata ji's ambition is to make her nephew Abhishek the chief minister, Stalin ji's interest is to make his son Udhayanidhi the chief minister and Gehlot ji's interest is to make Vaibhav the chief minister. Tell me, can they do your good? The time is coming for the country's public to decide whether to vote for the person who works for his son, or the person who is working for the country," said Shah.

"The support that I have seen across the country for Modi ji, it is certain that Naren-

dra Modi ji will once again become the Prime Minister in 2024 with 300 seats," said Shah.

Shah also spoke about the welfare schemes of the Modi government. "For the first time, 75 years after Independence, Narendra bhai has brought glory to all the adivasis in the country by making a tribal woman from a poor family, from Droupadi Murmu to Mahamahim Droupadi Murmu," said Shah, speaking at the tribal-dominated Udaipur.

Shah also accused the previous UPA government of failing to tackle terrorism.

"Ye nau saal mein, Modi ji ne desh ko surakshit kiya. Ye Sonia-Manmohan ki Sarkar thi, aye din Pakistan se Aliya, Maliya, Jamaliya ghus jaate aur hamare yahan bam dhamake karte the (Modi ji has made the country secure in these nine years. There was the Sonia-Manmohan government, every other day, Aliya, Maliya, Jamaliya would enter from Pakistan and carry out bomb blasts here)," said Shah.

Putin says learn from Make in India

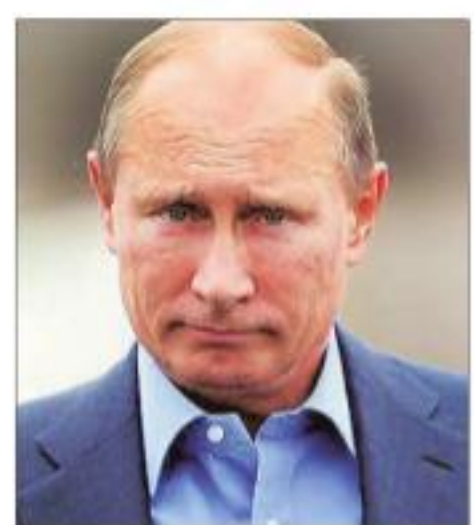
IN A TELEPHONE conversation on Friday, Prime Minister Narendra Modi and Russian President Vladimir Putin discussed the failed armed mutiny by the Wagner group among other issues.

"In connection with the events of June 24 in Russia, Narendra Modi expressed understanding and support for the decisive actions of the Russian leadership to protect law and order, ensure stability in the country and the security of its citizens," the Kremlin said in a statement.

"President Putin informed the PM about the recent developments in Russia. While discussing the situation in Ukraine, the PM reiterated his call for dialogue and diplomacy," the Prime Minister's Office (PMO) said.

The two leaders reviewed progress in bilateral cooperation and exchanged views on regional and global issues of mutual interest. Both leaders agreed to remain in touch and continue to make efforts to further strengthen the special and privileged strategic partnership between the two countries, the PMO said.

The conversation comes ahead of the virtual Shanghai



Cooperation Organisation (SCO) summit being hosted by India on July 4, which the two leaders will attend virtually.

On Thursday, at a forum in Moscow organised by Russia's Agency for Strategic Initiatives, Putin had called Modi "a big friend" of Russia and said his "Make in India" campaign has had a "truly impressive effect" on the country's economy, and it would "do no harm to emulate" it.

After their phone conversation on Friday, the Kremlin said: "Today, at the initiative of the Indian side, Russian President Vladimir Putin had a telephone conversation with Prime Minister of India Narendra Modi... When discussing topical issues of bilateral cooperation, they underscored the importance of further consistent implementation of the major joint pro-

jects in various areas and noted with satisfaction substantial growth in trade throughout 2022 and in the first quarter of this year."

Particular attention was paid to interaction within the SCO and the G20, in which India currently holds presidency, as well as in the BRICS format. In addition, Modi informed on his international contacts, including those during his recent visit to Washington.

"The situation around Ukraine was touched upon as well. The Russian President gave his assessment of the current state of affairs in the special military operation zone, having stressed Kiev's utter refusal to undertake political and diplomatic steps to resolve the conflict," the Kremlin said.

Calling the conversation "substantiative and constructive", it said the leaders reaffirmed their mutual intention to strengthen the special and privileged strategic partnership between Russia and India.

A day before, at a forum in Moscow organised by Russia's Agency for Strategic Initiatives (ASI), Putin had said, "Our friends in India and our big friend, Prime Minister Narendra Modi, launched the Make in India initiative several years ago.

E-counselling for WBJEE rankers to begin soon

PREPARATIONS ARE UNDERWAY for the e-counselling process for successful candidates of this year's West Bengal Joint Entrance Examination, chairman of the WBJEE Board Malayendu Saha said Friday.

The WBJEE is held for admission of students to engineering colleges in the state.

Saha said of 1,01,000 students who took the exams, around 97,000 students got rankings.

The board allotted a designated time interval between 'choice filling' and 'choice locking', allowing students to review a mock allotment of their seat, he said.

Students can modify their choices in the first round if they are dissatisfied with their allocated subject, Saha said. —PTI
