2. Bank guarantee invoked by Andhra Pradesh State Fibernet Limited of Rs 4.28 Crores. The said action was challenged by the company before the division bench of Andhra Pradesh High Court, Amaravathi, which is pending. Based on the legal opinion given by the counsel, the company has not made any provision in its books of accounts.

3. Orders issued by GST Department. Best Judgment assessment orders under section 62 have been passed by the GST Department - Andhra Pradesh for the period June 2020 to February 2021 for non-filing of GSTR-3B returns and raised a demand of Rs 3.6 Crores including interest of Rs. 0.733 Crores. Appeal has been filed with the department by the company requesting for extension of time for filing the returns and payment of taxes till the huge arrears due from AP SFL are realized. Appeals filed on 27.10.2021 before Appellate Deputy Commissioner, Commercial Taxes, Tirupathi against orders passed by GST department for the period from June 2020 to February 2021 as per the orders passed by the Honourable High Court of Andhra Pradesh. The Company received Best Judgment assessment orders under section 62 have been passed by the GST Department - Andhra Pradesh for the period March 2021 to May 2021 for non-filing of GSTR-3B returns and raised a demand of Rs 1.22 Crores including interest of Rs. 0.482 Crores, the company will file appeals against the same on or before 28.02.2022.

4. Orders issued by Appellate Deputy Commissioner (CT), Tirupathi. The order restricts the input availed by the company to 75% of the input claimed treating the service being executed as a Works contract instead of the supply and services contracts separately (AP SFL Project). A demand of Rs 21,45,869/- has been raised by the department including a penalty of Rs 4,29,018. The company filed an appeal on 05.10.2021 to challenge the proceedings before the APVAT Appellate Tribunal, Visakhapatnam.

5. Orders issued by Deputy Commissioner (CT) Guntur Division. The orders restricts the input availed by the company to 75% of the input claimed treating the work being executed as a Works contract instead of the supply and services contracts separately (AP Civil Supplies Project). A demand of Rs 6,96,746/- has been raised by the department. The company filed an appeal on 05.10.2021 to challenge the proceedings before the APVAT Appellate Tribunal, Visakhapatnam.

6. The Company has considered possible effects that may result from Covid-19 in preparation of these financial results including recoverability of its assets. In developing the assumptions relating to future uncertainties in the economic conditions due to Covid-19 it has, at the date of approval of these results considered relevant internal and external sources of information and expects that the carrying amount of these assets are recoverable. The impact of Covid-19 may be different from that estimated as at the date of approval of these financial results.

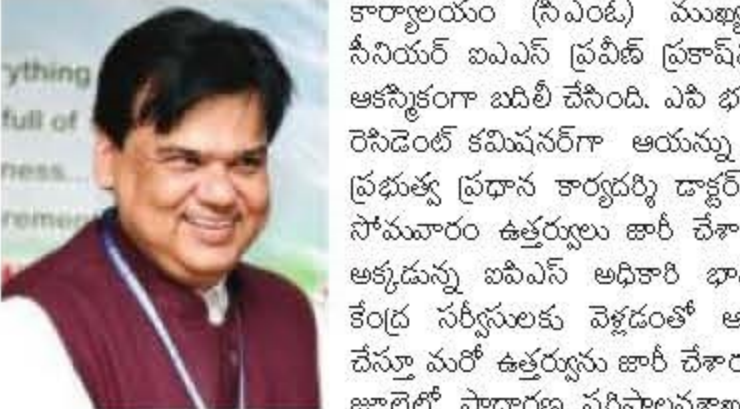
