The Stakeholders Relationship Committee of the Board of the Company in its meeting held on 27 April 2023, approved the allotment of 2,27,790 Warrants convertible into an equal number of equity shares of the Company of a face value of ₹ 10/- each in a dematerialized form, to each of the Allottees, at an issue price of ₹ 2,195 per Warrant, which, upon conversion into equity shares, shall rank pari-passu with the existing equity shares of the Company of ₹ 10/- each.

The Company received 25% (twenty-five percent) of the total consideration payable by each of the Allottees in respect of the same. The aforesaid amount of ₹ 25 Crores, has been temporarily invested in Liquid fund/s and shall be utilized as and when required by the Company for the objects stated in the explanatory statement to the notice for the General meeting.
