Proceedings of the 30th Annual General Meeting of the Company

The 30th Annual General Meeting of the Company was held at A/ 115, Siddhi Vinayak Towers, B/h DCP Office, Off S.G. Highway, Makarba, Ahmedabad- 380051 on Thursday, September 21, 2023 at 11.00 a.m.

Mr. Amam Shah, Chairman of the Company being present was appointed as the Chairman at the 30th AGM and thereafter he presided over the meeting. All the Directors of the Company attended the meeting. The Chairman welcomed all the Members and Special Invitees to the 30th AGM and commenced the proceedings.

It was noted that the Chairman of the Audit Committee, the Nomination and Remuneration Committee and the Investor Grievance cum Stakeholders' Relationship Committee were present at the Meeting. The requisite quorum being present, the Meeting was called to order. Thereafter, the Notice of the 30th AGM was taken as read as the same was already circulated to the Members. Further, the Members were informed that the Auditor's Report was free from any qualifications, observations or comments on financial transactions or matters which have an adverse effect on the functioning of the Company. He apprised the Members on the performance of the Company for the financial year 2023-24.

The members were informed that pursuant to Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company had provided remote e-voting facility to its members which started on September 18, 2023 from 09:00 a.m. and ended on September 20, 2023 at 05:00 p.m. The members present at the meeting who had not exercised their votes through the remote e-voting facility were provided ballot voting facility at the venue of the AGM.

The following items of business as set forth in the Notice of the AGM dated August 11, 2023 were transacted at the Meeting:

Ordinary Business:

1. Adoption of (a) the Audited Standalone Financial Statements of the Company for the financial year ended March 31, 2023 together with the Reports of the Board of Directors and the Auditors thereon and (b) the Audited Consolidated Financial Statements of the Company for the financial year ended March 31, 2023 together with the Auditors thereon
2. Re- appointment of Mrs Binoti Shah (DIN: 07161243), who retires by rotation and being eligible, offers herself for reappointment

3. Continuation of Mr. Bahubali Shah (DIN: 00347465) as the Director of the Company upon attaining age of 70 years
