जाम से मिलेगी मुक्ति, इसी मार्ग पर चल रहा है लेफ्ट टर्न का काम

क्योरवेल हॉस्पिटल और इंडस्टी हाउस को जोडने वाला न्य पलासिया की पुलिया (ओम शांति भवन से इंड्रस्टी हाउस के बीच) के चौड़ीकरण के लिए लम्बे समय से मामला अटका हुआ है। बताया गया है की पुलिया का चौड़ीकरण का कार्य इसी सप्ताह शुरू होगा, मगर इसके पहले निगम एक-दो दिन में पुल निर्माण की बाधाओं को हटाने का काम शुरू करेगा। पुल चौड़ा होने से राहगिरों को यातायात जाम से मुक्ति मिलेगी, क्योंकि अभी पुल संकरा होने से लंबा जाम लग जाता है।
