Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, an update relating to the impact of the COVID-19 pandemic on the operations of the Company is as follows:

Company got the letter from the German based machinery supplier M/s. Siempelkamp Maschinen – und Anlagenbau GmbH about applicability of Force Majeure Clause due to verse situation of COVID-19 pandemic in India.

By the said letter, they informed **to call back all it's personnel** as deployed by them at Company's MDF Board manufacturing plant located at Atchutapuram, Dist. Vishakhapatnam, State Andhra Pradesh. The personnel were deployed by the Siempelkamp as support for running the said new manufacturing unit at maximum capacity.

The impact of the said decision will be there, Company has further to wait of the personnel of machinery supplier to come back in India for support. Due to non-availability of personnel, the plant production capacity may be impacted to some extent and Company may not achieve it's desired production.
