Right of Way Rules Amended to Aid 5G Rollout

NEW DELHI: The Department of Telecommunications (DoT) has amended the Indian Telegraph Right of Way Rules (RoW) by definingaframework for laying overhead optical fibre cable (OFC), a move which can help create infrastructure necessary for the rollout of 5G technology in the country.

The amendment prescribes a one-time compensation of Rs 1,000 per kilometre for laying overhead OFC which will lead to a uniform levy/fee charged by the local authorities. The RoW Rules until now

covered only underground OFC and mobile towers.

"These amendments will ease RoW-related permission procedures for establishment and augmentation of digital communications infrastructure across the co-

untry," a statement

issued by the DoT sa-

id. It added that with a robust pan-India digital infrastructure, the digital divide between rural-urban and rich-poor would be bridged. Telecom industry body Cellular Operators Association of India (COAI) termed the move "progressive" and said: "...this directive stipulates that necessary infrastructure be built at the lowest logistical costs". The COAI has Bharti Airtel, Vodafone Idea and Reliance Jio Infocomm as its members. Another industry body, the DIPA (formerly TAI-PA) said the amendment had clearly laid the framework for laying overhead OFC and thus would go a long way in creating necessary infrastructure to cater to the forthcoming 5G rollouts.—Our Bureau

Mphasis Q2 Net Profit Rises 14% to ₹342 crore

PUNE: IT solutions provider Mphasis' net profit rose 14.1% to 341.5 crore in the quarter ended September 30, while revenue was up 17.4% at ₹2,869.22 crore from the corresponding period last year.

Adjusted for M&A charges, net profit jumped 19.5% to \$357.4 crore. In constant currency terms, revenue was 17.2% higher at \$385 million. Of this, direct revenue grew 31.8%.

Biocon Q2 Revenue Increases by 10%;

Profit Declines 18%

BENGALURU: India's largest bio-pharmaceutical company, Biocon, reported an 18% fall in net profit to ₹138 crore in the fiscal second quarter, on a one-time charge, while revenue grew by 10% to 1,945 crore.

Biocon's bottom line in the July-September quarter took a \$50 crore hit on account of exceptional items relating to the modification of optionally convertible debentures from an investment in subsidiary Biocon Biologics and the reversal of claims from the Service Exports from India Scheme for an earlier period, the company said late on Thursday. Net profit before exceptional items

grew 11% to \$188 crore in the quarter ended September 30, it said. Growth in revenue, it added, was driven by a strong performance in its research services and biosimilars business segments, which grew by 17% and 10%, respectively. Revenue from its generics business dropped by 12% year-on-year to \$530 crore. — Our Bureau
